

GeoScienceWorld Perpetual Access License Agreement

This Perpetual Access License Agreement for GeoScienceWorld eBooks Collections is by and between GeoScienceWorld (“GSW”), a registered nonprofit organization located in the Commonwealth of Virginia, and [REDACTED] (“Customer”) located at [REDACTED].

I. RIGHTS AND RESPONSIBILITIES

A. Authorized Users

The purchase of an eBook or eBook Collection license from GSW grants unlimited access to the full text of the eBook for educational, research, and other personal and noncommercial use by library patrons and other Authorized Users of the Purchaser's campus/institutional network through a specified IP or Proxy network or other authentication networks that is supported by GSW through its technology vendor(s).

Purchasers are expected to make their best feasible efforts to enable access to eBooks only to faculty, students, staff, and walk-in library patrons using the campus' physical library facilities. There are no contractual limits on the number of Authorized Users from one campus at any given time.

B. Permitted

Provided that the copyright header attached to the eBook chapter is retained in all cases, Authorized Users at the Purchaser's institution may

1. download and print one copy of each eBook chapter for personal use and archive contents on their own personal computers
2. send one copy of an eBook chapter by email, hard copy, or fax to one person in the Customer's campus/institutional network at another location for that individual's personal use
3. distribute a copy of individual eBook chapters in print or electronic form to Authorized Users
4. use a persistent URL, or durable URL, to an eBook chapter for courses of instruction offered by the Customer, where access is restricted to students enrolled in the course, to instructors, and to library staff maintaining the link, and such access is limited to the duration of the course. Each item should carry an appropriate acknowledgment of the source, copyright, and publisher, and the links to such items shall be deleted by the Purchaser when they are no longer required for such purpose.
5. supply to an authorized user of another library (whether by post, fax or secure electronic transmission, using Ariel or its equivalent, whereby the electronic file

is deleted immediately after printing) a single copy of an electronic original of an individual ebook chapter

6. place selected listings and notices on the campus network to inform users of availability
7. display, download or print purchased ebooks for the purpose of internal marketing or testing or for training Authorized Users or groups of Authorized Users

Regarding section B.2 above, if the Customer becomes aware of unauthorized access to GSW products or platforms it will notify GSW immediately and will cooperate in locating and attempting to stop the specific individuals who are abusing the service. If the specific abuser(s) cannot be identified or stopped, GSW has the right to withhold, suspend, or terminate access to any or all purchased content, without liability.

C. Not Permitted

Authorized Users at the Purchaser's institution may not

1. disseminate content from GSW outside the campus or institution by any means, except as noted above
2. transmit the digital source code, whether plain ASCII or tagged
3. use contents from GSW in course packs offered for sale
4. systematically download content by robots or other automatic processes without explicit approval from GSW
5. burden server(s) with activities, such as computer programs, that automatically download content, commonly known as web robots, spiders, crawlers, wanderers, or accelerators. If there is evidence that such unauthorized activities have taken place, the Customer will be contacted, and access to the offending IP address(es) may be blocked if a prompt resolution is not achieved. No refunds or credits will be given for time without access as a result of such activities.
6. remove, cover, overlay, obscure, block, or change any copyright notices, legends, or terms of use; or modify or create a derivative work of any content without the prior written permission of the copyright holder
7. re-use content for commercial use without prior written permission of the copyright holder
8. make agreements for access to GSW content with individuals, organizations, vendors, affiliates, or partners, who are not Authorized Users.

II. COPYRIGHT AND PERMISSIONS

Unless otherwise noted, third party Publishers hold the copyright on all eBooks on GSW, whether the material is in print or electronic form. All book content is subject to "fair use" provisions of U.S. or applicable international copyright laws [<http://www.copyright.gov/title17/92chap1.html>]. A list of the Publishers participating in GSW eBooks Collections may be found online or can be requested by contacting gswinfo@geoscienceworld.org. In the event of a dispute between a Publisher and any contributor with respect to the electronic distribution of any GSW eBook content, GSW shall have the right to remove such content, and will do so upon the Publisher's request.

Requests for authorization to distribute copies of ebook content for use outside of the provisions listed above may be sent to the Copyright Clearance Center (CCC). In preparing your request, please note the name of the copyright holder of the book and follow the CCC instructions for that copyright holder. No permission requests should be sent to GSW.

III. ACCESS AND AUTHENTICATION

Server(s) maintained by GSW or its technology provider(s) permit entry by recognizing authorized IP addresses. At the time an order is placed, the Customer will provide IP addresses for all institutional networks and computers that require access to GSW eBooks.

The Customer will make reasonable efforts to create and maintain appropriate security measures to ensure that only Authorized Users can access purchased content online. The Customer also affirms that all IP addresses provided for use of GSW eBooks are controlled by its institution exclusively for Internet access by Authorized Users. Valid IP addresses must not include those of publicly accessible proxy or cache servers.

IV. USAGE STATISTICS

GSW will provide the Customer with COUNTER-compliant usage data for eBooks within the Customer's collection(s). This data will be for use by GSW or for private, internal use by the Customer.

V. PERPETUAL ACCESS AND ARCHIVING

Providing that full payment of the total purchase price is made (per Clause VI below), the Customer retains the right to perpetual access to the digital version of the purchased eBooks on GSW's server(s). For access on GSW's server(s), which may be maintained by GSW or a technology provider that GSW, at its sole discretion, elects, GSW reserves the right to charge an annual fee to recover the costs for providing continuing access and customer support on the GSW platform. Said fees will be capped at 3% of the price of the collection or \$750 per year and may be subject from time to time to reasonable inflationary increases.

The Customer may participate in the LOCKSS (Lots of Copies Keeps Stuff Safe) system for archiving digitized publications. To benefit from this support, the Purchaser must install a LOCKSS cache at their institution. (See <http://www.lockss.org> for further information.) The Purchaser may perpetually use the LOCKSS system to archive and restore eBook content, so long as use is otherwise consistent with this Agreement. eBook content may be made available to other LOCKSS system Customers who can be verified by GSW as having rights through GSW to the identical eBook content.

VI. PURCHASE TERMS

A. eBook Access Activation

For access to be enabled, the Purchaser must provide technical and administrative data about its campus or institution on a GSW order form or by another mutually agreed upon method. The Customer will have access to ordered titles upon successful completion of the technical order set-up and authentication process.

B. Invoicing and Payment: GSW eBook Collections

GSW eBook Collections on GSW are available for a one-time fee, plus applicable ongoing fees in Section V above. When a Customer confirms an order for a GSW eBook Collection(s), an invoice will be generated for the Customer's selected eBooks. Payment is due within 30 days of invoice. Access to content from the eBook Collection(s) will be disabled should any amount invoiced remain unpaid for 60 or more days. Access to eBook content will be re-enabled only upon receipt of full payment of any outstanding invoices. Upon receipt of full payment, perpetual access rights are granted to the Customer.

C. eBook Content Delivery

GSW eBook Collections on GSW include both frontlist (newly published) and backlist (previously published) eBooks from participating Publishers. Some books may be offered for sale in advance of publication. GSW will make all reasonable efforts to provide access to digital versions of the books within 30 days of publication by the Publisher. In some cases, publication may be delayed by the Publisher beyond the initially announced publication date. In such cases, GSW will make all reasonable efforts to provide access to the digital version of a book within 30 days of its

availability from the publisher. Each GSW eBook Collection will be offered with a minimum guaranteed number of eBooks to be delivered for the purchase price; there are no guarantees that specific titles will be included in any particular collection. In the event that GSW delivers fewer books than the minimum guarantee for a specific GSW eBook Collection, the Customer will be offered a credit equivalent to the percentage of the price paid represented by the deficit against the guaranteed number of eBooks.

E. Multiple Collection Transactions

Successful execution of this Perpetual Access License Agreement provides for unlimited transactions for Perpetual Access eBook Collections and/or eBooks on GSW. If desired, this Agreement may be amended to list the specific GSW eBook Collections or eBook title lists acquired by the Customer over time.

VII. ADDITIONAL TERMS

If any provision or provisions of this License Agreement shall be held to be invalid, illegal, unenforceable, or in conflict with the law of any jurisdiction, the validity, legality, and enforceability of the remaining provisions shall not be in any way affected or impaired thereby.

GSW will not be held liable for any delays, inaccuracies, errors or omissions in the transmission or delivery of all or any part thereof, or for any damages arising from any of the foregoing. GSW does not represent, warrant, or endorse the accuracy or reliability of any content.

This License Agreement, including all rights and obligations and the license itself, may not be assigned or otherwise transferred by Purchaser, including by sublicense, and any purported assignment or transfer shall be void.

If the Customer becomes aware of infractions upon this Agreement, it shall report these to GSW immediately. This Agreement may not be assigned and represents the complete understanding as to the subject matter therein.

The Customer may signify its acknowledgement of future titles lists and fees by acceptance of invoice or purchase order or by signing an Addendum including an additional schedule of titles and corresponding fees.

The initial publications list under this Agreement and corresponding Schedules, corresponding to the fees set forth in Schedule B, is included in an accompanying PDF file. For this Customer, the attached list is for the [insert name of Collection(s) being purchased].

Per Section VI (C) of this Agreement, the *minimum guaranteed number* of eBooks to be delivered is 90% of the quantity of titles appearing on the accompanying list. While it may also be the case that more are delivered, this provides for unanticipated issues that can arise during the file delivery and loading process, which may require removal of specific file(s).
